Ordinary or Branch Fellowship of The Historical Association (FHA)

Ordinary Fellowship of the HA is open to any full member of the HA who meets at least one of the criteria below.

Members may nominate themselves, or be nominated by an HA branch. Awards of Ordinary Fellowship of the HA can be made within an HA branch, or can be sent from head office directly to a New Fellow.

Nominations can be made at any time of year, and should be made to the CEO. Nominations will be considered by the Executive Committee, who meet four times per year. Decisions about Fellowships can also be made in between Executive Committee by email.

Applications for Fellowships by email are encouraged. This document is editable for that purpose.

Criteria for HA Fellowship nomination:

- 1. S/he has made a significant contribution over time to the HA by serving as an officer at branch or national level (i.e. as a branch president, secretary or treasurer, OR as a chair of one of the national committees such as Publications, Secondary, Primary, Local History, or the Young Historians' scheme, OR as an editor of one of the HA's journals, OR as a Vice President, Deputy President, President, Honorary Secretary or Honorary Treasurer, OR by serving in any combination of such posts over several years).
- 2. S/he has made a significant contribution to the teaching of History at any level by serving, for example, for some time as a Head of Department in a school, college or university, OR by playing a leading role in introducing a new curriculum or devising a new form of assessment, OR by holding a senior post responsible for training history teachers or for their career development, OR by acting in a significant capacity as an examiner, OR promoting the study of history outside one's normal role or hours, etc.
- 3. S/he has made a significant contribution to historical scholarship OR to the teaching of history by publication in print or electronic form.
- 4. S/he can clearly demonstrate by some other means that s/he has made a significant contribution to the promotion of an interest in or knowledge of history.

Applications are free and can be made by an individual member of the association, corporate members are not eligible.

Any member of the Historical Association who wishes to apply for the Fellowship must submit an application form and also ensure that two supporting reference forms are returned independently to the HA.
